Problem behaviors in children with autism remain one of the most difficult areas for practitioners and parents. They prevent learning, participation in activities, and hinder the development of relationships. Behavior management approaches remain constrained, as they have not yet infused a developmental and relationship-based perspective that focuses on enhancing children's emotional regulatory abilities, and developing positive, trusting relationships with others. Recent research documents the need to go beyond behaviorally-oriented approaches by incorporating developmental, emotional regulatory and relationship-based dimensions. Participants will learn about practical, respectful and innovative ways to assess, prevent and support a child with problem behaviors, and to design learning environments, supports and activities that support a child's ability to stay well-regulated emotionally, to maximize learning, social participation and relationships.

Dr. Barry Prizant has more than 40 years experience as a clinical scholar, researcher and consultant to children and adults with ASD and related communication and developmental disabilities and their families. He is an Adjunct Professor in the Center for the Study of Human Development, and Director of Childhood Communication Services, a private practice. Previously, he served as an Associate Professor of Child and Adolescent Psychiatry in the Brown University Program in Medicine, and as a tenured Professor in the MS and Ph.D. Communication Disorders programs at Southern Illinois University and Emerson College. Currently, he consults for numerous school districts and agencies throughout the US and internationally, and is the co-founder and co-facilitator of weekend retreats for parents of children with autism for the past 18 years.

These complexities stem from multiple factors including the diversity of developmental, social and emotional functioning of children receiving an ASD diagnosis, the common co-occurrence of mental health issues also warranting treatment, the differing philosophies regarding what is important to treat/teach, as well as the complicated and often conflicting research and clinical literature regarding how best to do this. Finally, a general model for individualizing treatment planning will be illustrated. The workshop incorporates use of video and audio clips.
